### 1. Privacy Statement

Our privacy practices comply with:

- The Data Protection Directive of the European Union and the Principles of Safe Harbor Program (Safe Harbor) of the Department of Commerce of the United States relating to the notice, choice, onward transfer, security, data integrity, access and execution.
- Data protection laws applicable in the country and of national, state and local (some country's laws require country specific information in a privacy policy).

Personal information is not available to any other person other than those related to the specific function for which re picks. We recognize the need for appropriate protection and management of personal information that you provide us. BY SUBMITTING PERSONAL INFORMATION TO GAB, AND / OR ACCESSING AND USING THE WEB SITE, YOU AGREE TO CONFORM GAB THAT MAY COLLECT, USE AND DISCLOSE SUCH PERSONAL INFORMATION IN ACCORDANCE WITH THIS PRIVACY POLICY AND TERMS AND CONDITIONS ARE PERMITTED BY ACT OR REQUIRED ACCORDING TO THE SAME.

## 3. Consent to share and disseminate information, including International Information Transfers

Besides giving consent related to this Privacy Policy and the Terms and Conditions, including any relevant supporting policies, you expressly consent to GAB to share information you have provided, as described herein. COMERCIALIZADORA GAB can share information with other companies from Group U. Similarly, GAB can share information with companies that provide support services to it, such as credit card processing, courier companies, web hosts, support providers, fulfillment centers or other service providers, or to put running or investigate actions or business operations, as these companies they may need information about

you in order to carry out their functions. These companies are not permitted to use the information we share with them GAB another purpose, but does not control such companies GAB. # 4. Consent to receive electronic notification in the event of a security violation

# 9. Collection and Use of Personal Information of Employees

### 14. Share Personal Information

GAB does not sell personal information to others. We may share Personal Information with our service providers, consultants and U Group companies except as described in this Privacy Policy, GAB will not share personal information with a third party, unless a customer requests, consents to such disclosure, or disclosure is required or authorized by law

We may share your Personal Information with agents, subsidiaries or service providers who act for or on behalf of GAB in relation to the business of GAB, or for further processing of information in accordance with the purposes for which the information was originally collected any. We demand that our agents, subsidiaries or service providers agree in writing to maintain the confidentiality and security of personal information they hold on behalf of GAB and not use it for other purposes other than the purpose for which we hired them. Also require that third parties we hire to protect personal information we have disclosed in accordance with all applicable privacy requirements and general privacy principles described in this Privacy Policy.

The Personal Information you provide to GAB is considered a company asset and may be disclosed and / or transferred to third parties in the event of a purchase, sale, lease, merger or any other type of acquisition, disposal, or proposed or actual financing, of all or any part of GAB or any business or assets or shares of GAB or a division thereof for a customer continues to receive the same products and services from third parties
